What is an Endowment?

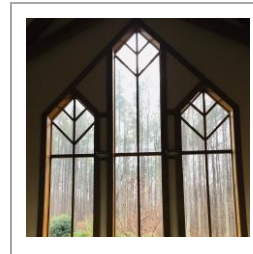
- Endowment funds provide a steady stream of income, no matter how the markets are performing.
- **Income generated by an endowment assists the church forever with new and ongoing initiatives.**
- **Endowment gifts are an expression of our faith, providing perpetual support outside of our annual operating budget.**
- **An endowment gift may provide a *tax benefit* to the donor depending on their circumstances; consult with financial advisors for guidance.**
- **Endowment gifts cannot be revoked.**
- **CITP's Endowment Fund is with the Presbyterian Foundation which has managed church endowments for centuries with a professional, proven track record of success.**
- **Once established, an endowment gift needs no more maintenance by donors, church leadership, nor staff; the Foundation is responsible for investment performance, reporting, and distribution of income as established in a legally-binding contract.**

Why Now?

- **Members re-evaluating their wills and reviewing bequest plans have inquired if we have a formal endowment.**
- **Projects outside the realm of our operating budget could be considered for funding, when identified as a need, via endowment income, rather than ignored or delayed or via a special fundraising campaign.**
- **Our church's demographics lean toward successful endowment outcomes.**

Discuss with your family, lawyer, or financial advisor your desire to make a transformative gift to grow CITP's Endowment Fund.

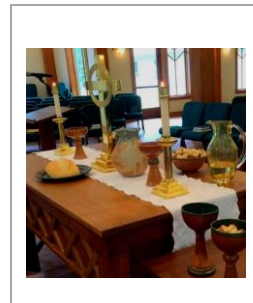
After determining an amount that you and they feel comfortable with, discuss with our pastor and/or treasurer.
