Dear Chapel in the Pines Congregation,

Annually in August, materials are sent to members about our endowment and planned giving opportunities to share with advisors and family during end-of-year tax discussions. Waiting until the holidays may be too late for making decisions and processing documents, so we trust getting this to you early will be beneficial to all.

Chapel in the Pines Presbyterian Church, Inc., (the legal name of our church for Wills and Bequests), established an Endowment Fund in 2023 under the watchful eyes of the Presbyterian Foundation (PCUSA), a leader in church endowment management for over two centuries with 7,000 endowments and over \$2 billion under management.

Enclosed is a **Planned Giving Opportunities** brochure to share with family members, attorneys, and financial advisors. Any of the methods highlighted in the brochure can help expand our church's endowment and ministries for generations of believers to come.

On June 30, 2025, our Endowment Fund's investment with the Foundation was nearly \$65,000. We are pleased that several members recently notified our treasurer of additions to, or changes in, their Wills to benefit our endowment. These are indeed wonderful endorsements of our church's ministries and future direction.

Young families within our church might consider how gift planning can assist in guiding loved ones regarding their wishes for legacy giving. Establishing a Will to protect children from probate challenges is a wise decision to make sooner than later. If this annual reminder of estate planning protects our youngest disciples and their futures, we have accomplished a valuable service, indeed. May it be so.
